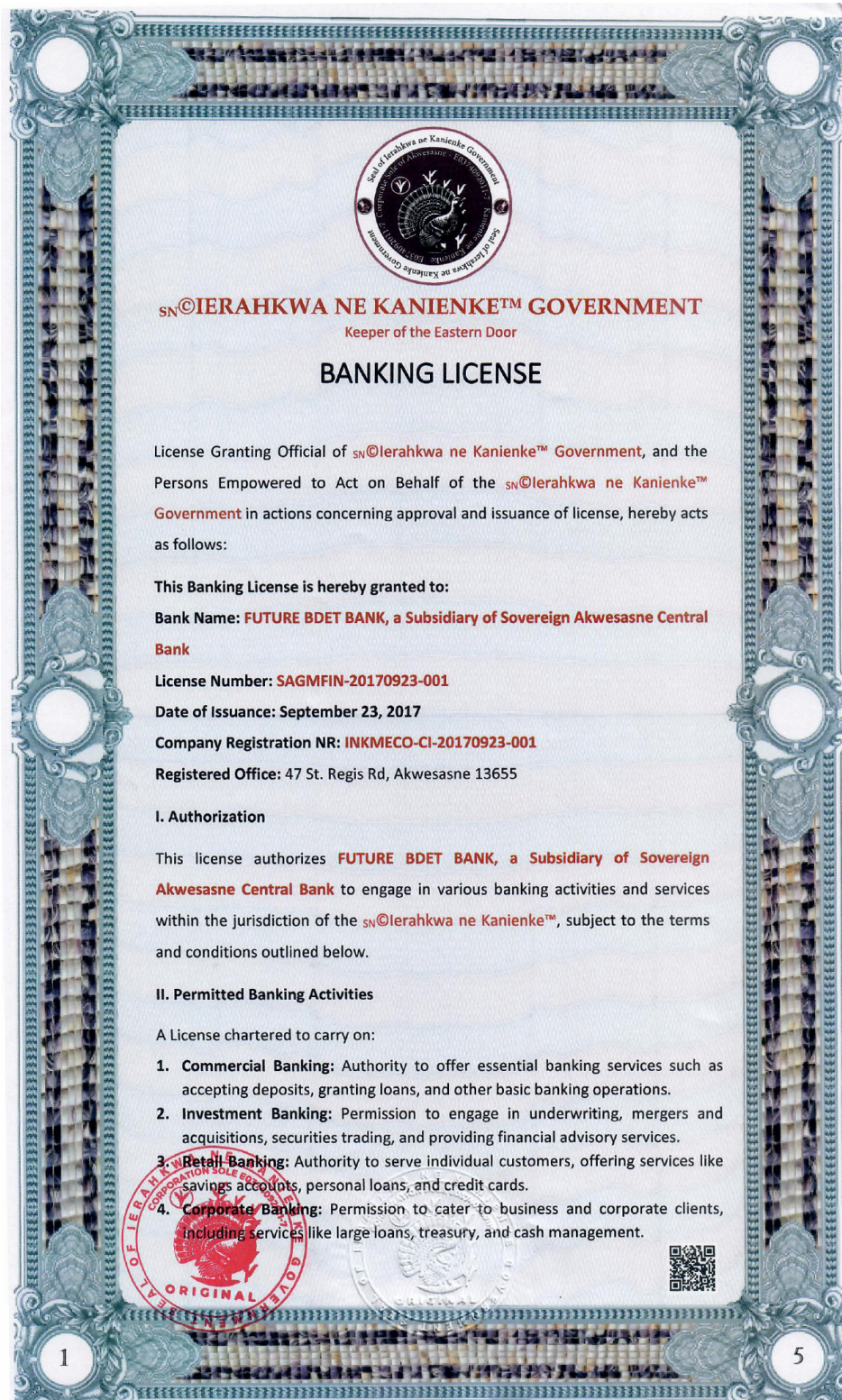


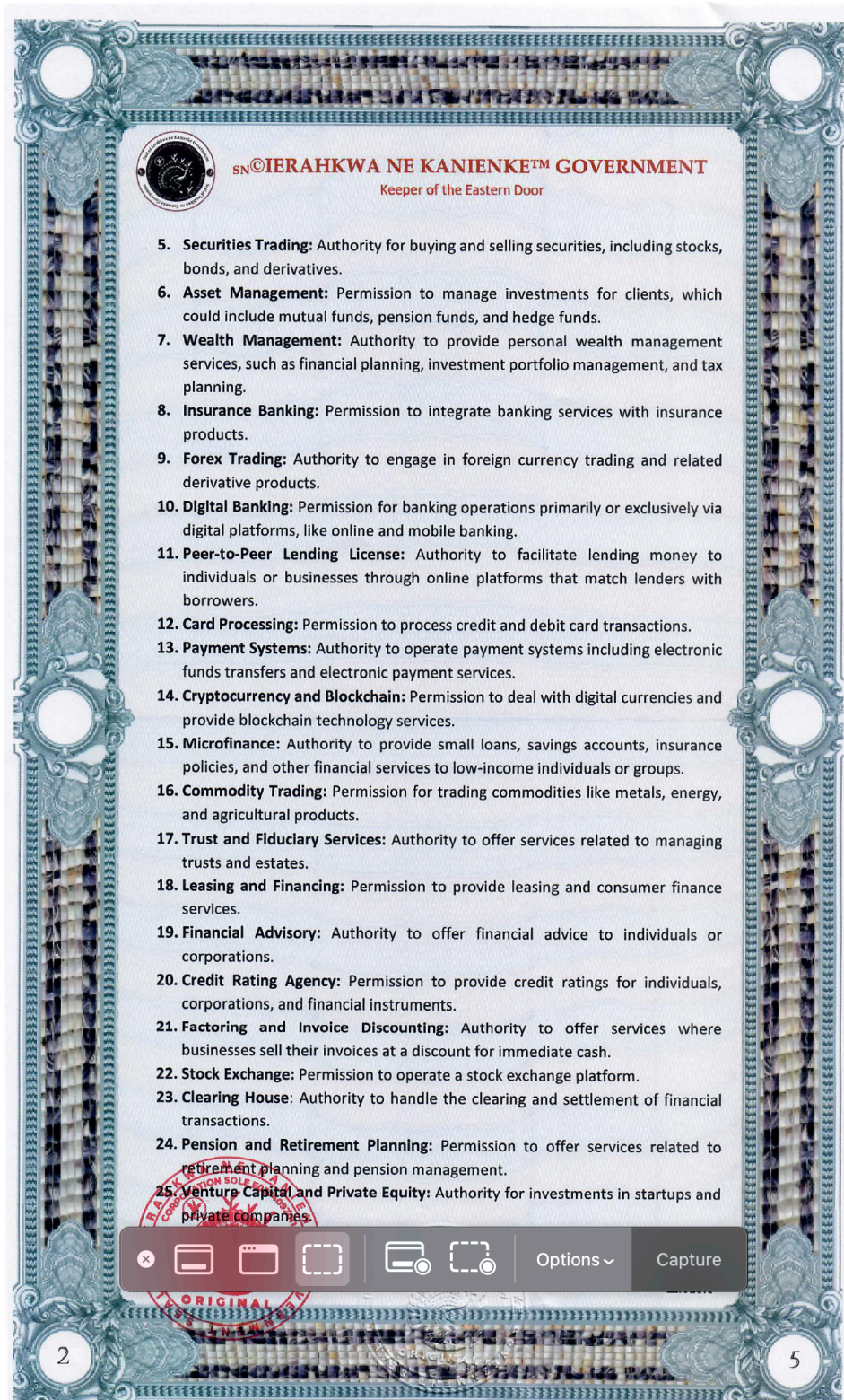

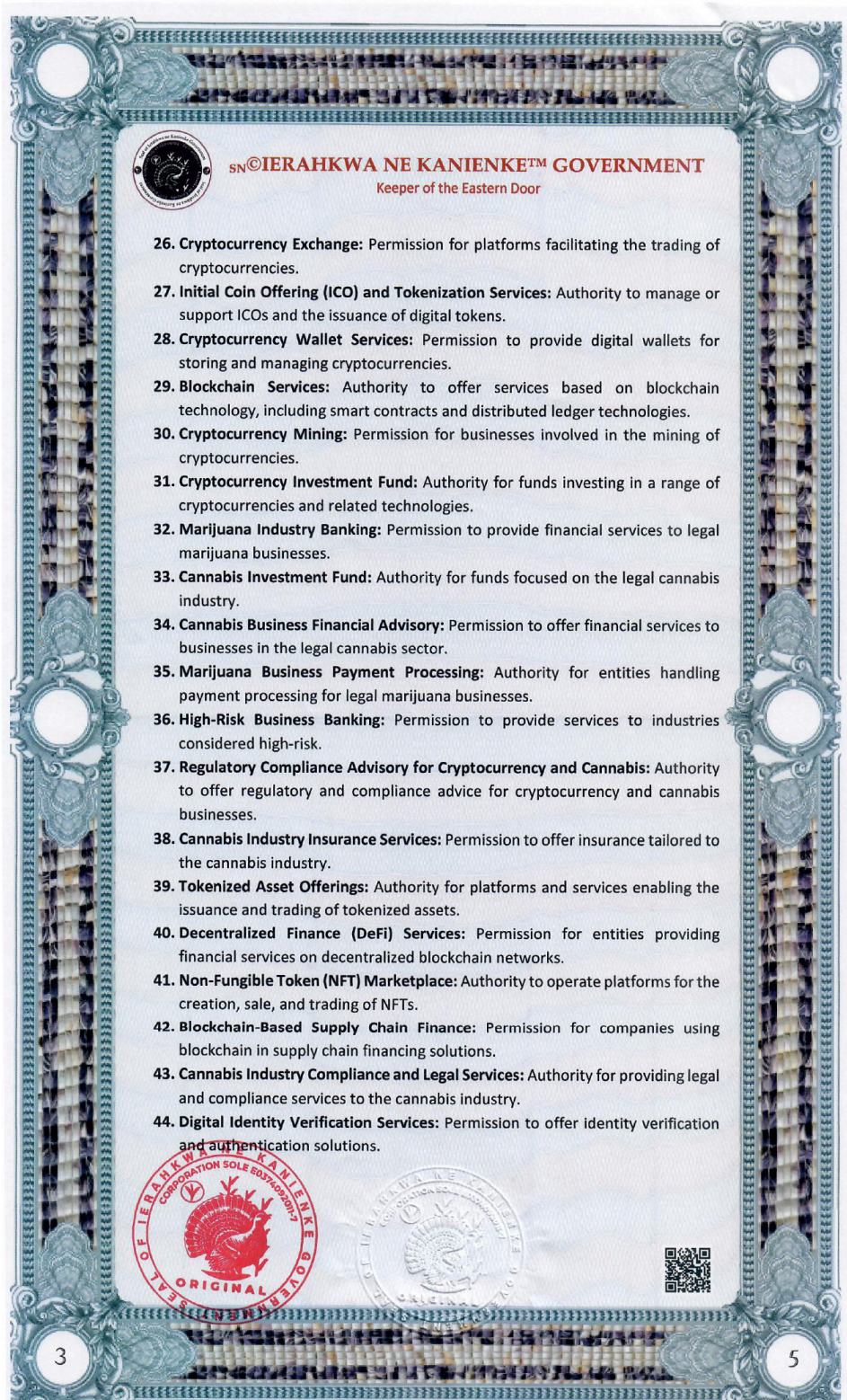

III. Compliance and Regulation

FUTURE BDET BANK, a Subsidiary of Sovereign Akwesasne Central Bank hereby acknowledges its commitment to full compliance with the SN@Ierakhwa ne Kanienke™ Government Law, including all associated regulations and governance standards. This banking charter, issued by SN@Ierakhwa ne Kanienke™ Government Foreign Jurisdictions, extends to operations within Diplomatic Extraterritorial Trade Mission Offices (ETMO) and International Foreign Territories under Diplomatic Agreements. These provisions authorize FUTURE BDET BANK, a Subsidiary of Sovereign Akwesasne Central Bank to perform banking activities in foreign territories and diplomatic offices governed by SN@Ierakhwa ne Kanienke™ Government, valid until further notice.

As an authorized financial institution in Akwesasne, an internationally recognized independent sovereign nation and state, FUTURE BDET BANK, a Subsidiary of Sovereign Akwesasne Central Bank is obligated to adhere to all applicable banking norms as stipulated by SN@Ierakhwa ne Kanienke™ Government. This includes, but is not limited to, standards in capital adequacy, risk management, anti-money laundering (AML), and countering the financing of terrorism (CFT).



